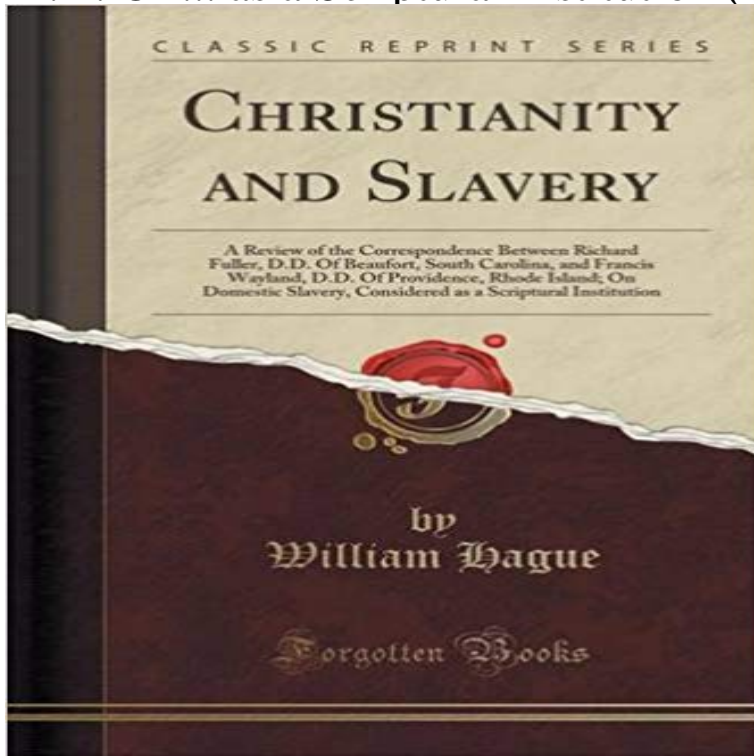

Having long been a sincere admirer of Dr. Wayland as a writer, a philosopher, and a teacher, he could not but regret the more deeply, on that account, the position taken by him, as to the manner in which primitive Christianity treated slavery; but then, he had no doubt that some of his brethren more immediately connected with the periodical press would do justice to that main part of the discussion. No such review, however, has appeared. Some time since, at a social meeting of the Boston Conference of Ministers, the writer was led to express his disappointment as to this matter, and to state his view of the scriptural argument.
