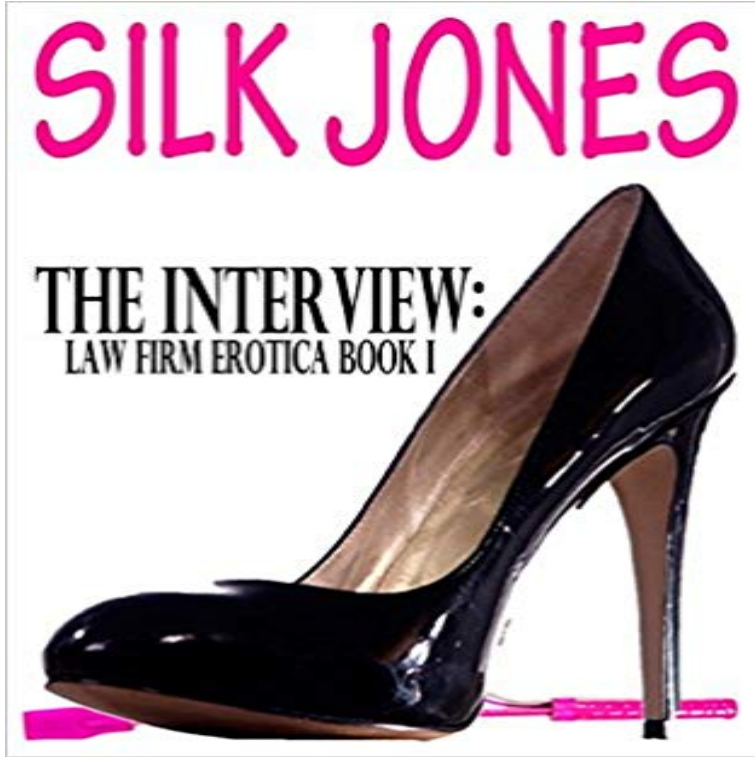


The Interview: Law Firm Erotica Book 1 (Volume 1)
