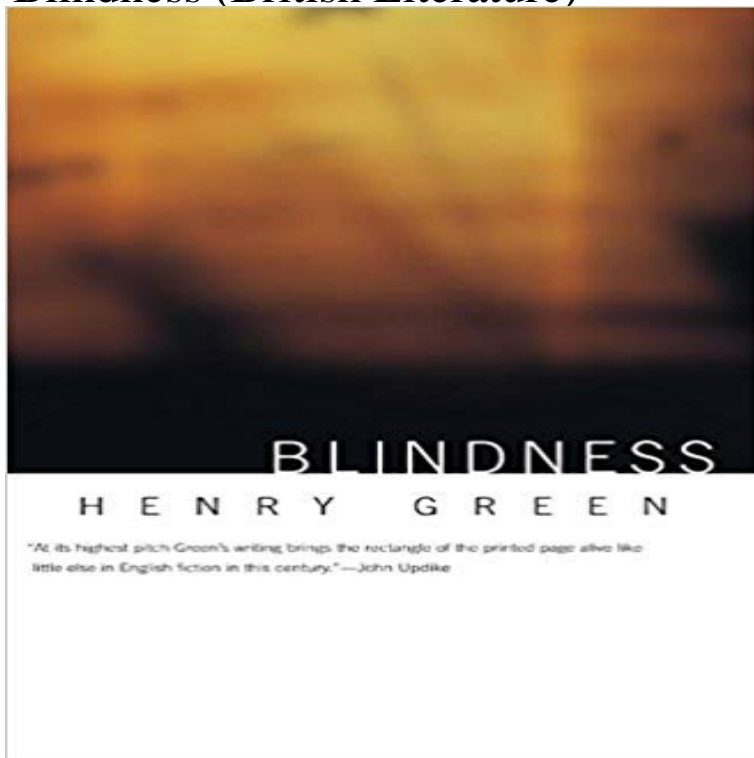


Blindness (British Literature)
